The meeting of Marhamchurch Parish Council was held on the above date at 7:30pm, in The Bray, Marhamchurch Village Hall.

6 members of the public were present for the meeting. Chairman Cllr Perry opened the meeting and welcomed everyone.

a) Decision Notices/Updates:

- (i) **PA26/04619** | Works to trees in a conservation area - works include T5: Common Ash: Remove deadwood. T6: Common Ash: Remove small dead Ash from under canopy. G3: Remove Ash with dieback. Crown lift remaining trees over play area to ensure 4m clearance from ground level in summer months removing third order branches only. G4: Crown lift over play area to clear play equipment by 3m when in full leaf. T3: Common Ash: Fell both stems and remove small Norway Maple under canopy with no longterm potential. T4: Italian Alder: Crown lift over swings to clear by 4m when in full leaf, removing third order branches only| The Revel Field Pinch Hill Marhamchurch.

Decided not to make a Tree Preservation Order.

- (ii) **PA26/04618** | Works to Tree within a Conservation Area - T1 - Cornish Elm and smaller dead Elm to north and T9 - Cornish Elm - Fell all to ground level |The Revel Field Pinch Hill Marhamchurch.

Decided not to make a Tree Preservation Order.

Clerk updated that this means that the necessary work can go ahead (as advised from Tree Surveyor) in Marhamchurch Playpark and Revel Field. Clerk has made contact with agreed contractor.

b) Planning Applications/Appeals:

Any late planning applications received will be discussed but not decided under this section.

- (i) **PA26/04981** | Construction of two replacement self-build dwellings including demolition of existing dwellings|Land And Buildings At The Bay View Inn Marine Drive Widemouth Bay.

Cllr Edwards read email from applicant, which was noted by Cllrs. Following a review of application and discussion a proposal of NO COMMENT was made by Cllr O'Sullivan. There was no seconder for the proposal.

A proposal of NO OBJECTION was made by Cllr Biddick-Bray. Seconded by Cllr Edwards. 4 voted in favour. 1 abstained.

- (ii) **PA26/05259** | Application for Permission in Principle for the construction of up to 9 dwellings (minimum of 5, maximum of 9) | Land East Of Willow End Hobbacott Lane Marhamchurch.

Following a detailed discussion and review of the application it was unanimously agreed to OBJECT to the application based on the following concerns:

> Access - the area already has a high volume of traffic and is a narrow country road not made for large vehicles.

> Drainage and sewerage - the system cannot cope already and further pressures from proposed development will continue to add to the problems.

> There is no natural 'site' or boundary linked to this application. No hedge or stream.

> Proposed development is in open countryside. Further light pollution is a concern.

> There are already 53 properties approved (or under review) for development in Marhamchurch area. Is there a NEED for 9 more properties.

Proposal to OBJECT to application was made by Cllr Edwards, Seconded Cllr Biddick-Bray. Unanimous.
